How to Reference Journal Articles in APA Format

In Harvard style, to reference a journal article, you need the author name (s), the year, the article title, the journal name, the volume and issue numbers, and the page range on which the article appears. If you accessed the article online, add a DOI (digital object identifier) if available. Author surname, initial.

Harvard Referencing for Journal Articles | Templates ...

The foundation of the reference is the same as for a journal article. Include the description [Supplemental material] in square brackets after the article title. If you cite both the main article and the supplemental material, provide only a reference for the article.

Give an in-text citation (i.e. in brackets or footnotes, depending on the style you are using) at the place where they are included in your writing and a full citation in the bibliography or reference list for the text you got them from. This includes graphs and tables, as well as illustrations and photographs.

To cite an online journal or newspaper article, the page numbers section from the print journal or newspaper reference is swapped with the URL or DOI the article can be accessed from and when it was accessed. So the reference for an online journal article is: Author surname (s), initial (s).

### How to Cite Sources in Harvard Citation Format - Mendeley

Here you find examples of how to write the reference list according to Harvard (a parenthetical referencing style also called the author-year or author-title style). When creating the reference list, sources should always be arranged in alphabetical order, sorted by the first author's last name or equivalent. Books with one author

You should include the year of publication or a more specific date if appropriate, for journal or newspaper articles/stories. For webpages look for the when the page was last updated. Include dates in brackets (2020) after author information. If no date can be established, then put (no date).

This is a guide on how to write references for various documents using the Oxford style intended for footnotes with complete bibliographic information. The guide is based on The Chicago Manual of Style Online. All sources used are listed in alphabetical order in a reference list at the end of the document, but before any attachments.

### Oxford - writing reference list

In your reference list entry for a journal article or other online source, APA currently recommends writing the full DOI address that gives access to the article. For example: <https://doi.org/10.1037/rev0000126>. The old guidelines were to present DOIs by writing "doi:" followed by the numerical string. For example: doi:10.1037/rev0000126

### How to Cite a Journal Article in APA Style | Format & Examples

A journal article retrieved from a library database can be referenced as though it were a print journal. The essential elements you require to create a journal article reference include: Author or authors including surname and initial. [Call out: include the second initial if available]; Year of publication, Title of article.

How to write a reference list Here are some general guidelines on how to lay out references for publication in the Pharmaceutical Journal: Authors should focus on recent papers and papers older than five years should not be included except for an overriding purpose.

In general, a reference will include authors' names and initials, the title of the article, name of the journal, volume and issue, date, page numbers and DOI. On ScienceDirect, articles are linked to their original source (if also published on ScienceDirect) or to their Scopus record, so including the DOI can help link to the correct article.

To begin writing in your journal, label your first entry with the date, time and, optionally, location. For instance, you might start with "Monday, January 1, 1.00p.m., Bedroom". Next, if you'd like to, write a salutation. Many journal-writers like to use "Dear Journal" or a similar greeting to start each entry.

Reference Style and Format The list of references should be alphabetically by the last name of the first author, and numbered serially. Citations in the text should be identified by appropriate numbers in square brackets, and consecutive references should be concatenated (e.g. [7, 12-15]). The names of all authors should be listed.
